

TDF Through the Years

As we look back on The Dressage Foundation's past 35 years, we're proud to continue the mission that Lowell Boomer put into place when he founded TDF in 1989.

Thanks to the generosity of many, TDF has consistently grown through the years, increasing the financial support that is available to those who are dedicated to dressage.

While there have been many successes in the past three-plus decades, notable achievements include:

TDF was established in Lincoln, Nebraska, by Lowell Boomer.

First annual meeting held in Lincoln.

1995 Violet Hopkins Fund was created to support educational events organized by USDF's nationwide Group Member Organizations.

Century Club was formed at the suggestion of Dr. Max Gahwyler to honor senior riders and horses, and to encourage their continuation in the sport.

2000 Michael Poulin proposed the Young Rider European Training/Education Program and the inaugural trip to Europe was held. This is now known as our Dream Program.

Gifted Memorial Fund for Adult Amateurs awarded its first grants.

First \$25,000 Anne Barlow-Ramsay Grant for U.S.-Bred
Horses and \$25,000 Carol Lavell Advanced Dressage Prize were awarded.

Donations enabled TDF to purchase a permanent office space in Lincoln, Nebraska.

Boomer Family Fund was established to provide future organizational support for TDF.

TDF expands grants to support Western dressage and paradressage riders.

2021 \$25,000 Debbie McDonald FEI Rider Fund established.

Record amount of grants will be awarded!

Adrienne Lyle's journey to becoming one of the top U.S. dressage riders is a story of talent, dedication, and support from the U.S. dressage community. TDF has been proud to help Adrienne at different points in her career, providing opportunities to help her succeed. Today, Adrienne not only shines as a top rider, but also knows the importance of giving back and helping others.

TDF first met Adrienne Lyle in 2005, when she was selected to participate in our Young Rider Dream Program trip to Europe. Adrienne returned from that trip with big goals and dreams.

Over the next several years, Adrienne worked hard to hone her skills and rise to the top of the sport, which led to her being selected for Team USA at the 2012 Olympic Games. Then TDF had the opportunity to help Adrienne in 2018 with a grant from our Dr. Anne Barlow-Ramsay Fund for U.S. Bred Horses. With that financial

support, she trained and competed Harmony's Duval in Europe.

These opportunities helped expand Adrienne's knowledge, giving her the experience needed to compete successfully on the dressage world's biggest stages. Now, twice within the past three years, we've been proud to cheer for Adrienne as a member of two U.S. Olympic Teams.

The story doesn't stop there, because Adrienne recognizes the importance of paying it forward to help others. One way that she gives back to the dressage community is by donating her time to our Young Rider Dream Program, the same program she participated in nearly two decades ago.

Adrienne said, "The Dressage Foundation is truly a game changer for many aspiring riders! Their generous grants help bridge the gap from dreams to reality. TDF has helped me tremendously in my career, giving me the opportunity to experience first-hand, top international dressage in Europe, which opened my eyes to what exactly my goals and aspirations were. Advancing Through Education

When Sarah Geikie applied for TDF's Major Anders Lindgren Grant in 2011, she was already a successful Grand Prix dressage rider, popular instructor/trainer, and FEI judge. Even with that success, Sarah knew the importance of continuing her education to not only help her students, but to reach her personal goals.

Sarah said, "I was shocked and excited beyond belief when I was awarded the grant to further my education. At that time, I had an active farm with many clients and horses that I was responsible for. In addition, I had a family. It was the support of my wonderful husband and clients that made it possible for me to travel to Florida for the training. I knew that the knowledge I gained from this experience would be transferred to my students and horses."

Thanks to the funding from TDF, Sarah was able to train with Kathy Connelly in Florida for six weeks. She said, "The opportunity to train intensively, without the distractions of normal daily life at home was just what I needed. In Florida, I was able to really concentrate only on my horse and myself.

"Almost every day, I would spend time watching some of the other lessons that Kathy would teach. Debbie McDonald was also based at the farm, so I was able to watch Debbie work with other riders and horses. There was so much to learn just by opening my eyes and ears.

"That was a fantastic trip for me. I went home excited about riding and training, and felt like I had a new lease on my career."

Now, years after Sarah received the TDF grant, she remains as committed as ever to the education of riders across the country. She

is currently co-chair of the USDF Instructor/ Trainer Development Program Committee, a USDF Certified Instructor, a USEF 'S' judge, and Level 3 FEI judge. As an instructor, she's taught thousands of riders across the country. As a judge, she's traveled the world.

Sarah's dedication to the dressage community continues in other ways, too. As another way to give back, Sarah joined the Board of Directors of The Dressage Foundation in 2015 and has been part of the organization since then.

"Continuing education is so important to any professional," Sarah recently said. "When you stop learning, you stop growing. I have found throughout my career that as I continued to learn and improve, I not only expanded my skills and communication ability, but also attracted additional clients and students. In a sense, the more you grow through education, the more you are essentially reinventing yourself."

THEN – "Receiving the Michael Poulin Fund Grant in 2006 was such a hugely pivotal moment in my career. After winning the

inaugural Brentina Cup on my homebred, home-trained stallion, Olivier, I was invited to Europe to work with then U.S. Coach Klaus Balkenhol. I had no idea how I would come up with the money (as a 22-year-old!) and so many people stepped in to help and encouraged me

to go for that once-in-a-lifetime opportunity. To receive the support from TDF to fuel what became a phenomenal international career for a home-bred horse was pretty special."

NOW – "Since then, I've coached students to CDI wins, the US Dressage Finals, and many regional awards, as well as having multiple students in the Emerging Athlete, Young Rider, and Young Horse programs. But for me, the biggest reward is showing up every day for my students and teaching them to be better horsemen. I absolutely credit experiences made possible through TDF for a strong barometer of right and wrong in the training and care of horses."

Between the generous Gifted Fund grant in 2009 and that glorious recent event in 2022, my three children graduated from college and married, and I survived Stage 3 ovarian cancer with the kind support of my husband, Lee. I just cannot thank The Dressage Foundation enough for the support. Please know what a happy difference you make in people's lives."

The Incredible Titleist:

From Gifted Fund to Century Club

IN 2012, Cean Embrey (TX) received TDF's Gifted Memorial Fund for Adult Amateurs Grant to support training for her and her then



12-year-old Dutch Warmblood gelding, Titleist. Titleist was not just any horse; he was literally born into Cean's arms. Cean recalls, "Titleist's momma gave birth to him standing up. I caught him in mid-air, falling backwards, and

the weight of this slimy newborn foal pinned me to the ground. When this adorable, wet, trembling foal lying heavy across my chest looked into my eyes, it was love at first sight. We immediately bonded deeply."


Under the guidance of Cean's longtime trainer, Carol Schmickrath, Cean raised, trained, and competed with Titleist through the levels. From Training Level through Fourth Level, the pair consistently ranked in the top 20 for Adult Amateurs in the country. Then, with the support of TDF's Gifted Memorial Fund grant in 2012, Cean and Titleist trained intensively to prepare for their Prix St. Georges debut. Their debut was both a learning experience and a success, with Cean pleased by their score of 63.7%.

Titleist and Cean continued progressing up to Grand Prix, and in 2019, they achieved their USDF gold medal. When it was time for Titleist to retire from the show ring, he went to live with Carol, where he became a beloved schoolmaster. Carol describes her relationship with Titleist

as embodying "the very essence of dressage, one of paying it forward."

For a final hurrah, on a beautiful June 2024 evening, Titleist carried Carol through a Grand Prix test to join the Century Club together. The ride was part of a larger event, "Starlight Symphony with a Side of Dressage," where a packed arena enjoyed live symphony music and multiple dressage performances. Cean said, "Carol and Titleist were graceful, elegant, beautiful, relaxed, happy, and the whole Grand Prix ride flowed so peacefully and freely."

After the ride, Cean said, "A crowd gathered at the gate as Carol and Titleist exited the arena, showering them with compliments and asking for photos. Kids wanted to pet Titleist's nose, and everyone was smiling." For Cean, Carol, and many others, it was a magical night and an opportunity to celebrate a truly special horse.



All About the Century Club

SINCE 1996, TDF's Century Club hasn't just honored the senior riders and horses of our sport—it has celebrated wisdom, experience, and love of horses.

The Century Club is special because it welcomes riders and horses with various backgrounds and experiences. Some members have been riding their whole lives, while others took their first riding lesson in their 70s. Some have spent years working to master dressage, while others ride down the centerline for the very first time to join the Club.



In January 2024, Margaret Duprey along with other donors, enabled five young riders to have the experience of a lifetime with their first trip to Wellington, Florida, as part of this year's Young Rider Dream Program!

Bella Perkins (NY), Caroline Colby (NH), Chloe Roth (SC), Katie Staib (PA), and Kylia Baker (CA) were accompanied by chaperone Kelly Irving-Burris (WA). The group learned from top professionals including Olympians Adrienne Lyle and Rebecca Hart; they visited numerous barns; and thanks to the generosity of Adequan, had front row seats at the Adequan Global Dressage Festival.

The young riders shared some key take-aways from the week:

Equine Industry Relationships

• It is important to foster healthy

• It was evident that the trainers we met not only work hard, but work with integrity, humility, and kindness. These traits are key to having successful careers and relationships with others in the industry.

• People, clients, horses, and teammates will come in and out of your life, and you never know what good will come out of any situation.

Sponsorships and Partnerships

- Align yourself with good, ethical people.
- It is important to keep sponsors involved in the training process to ensure everyone is on the same page.
- Understand everyone's goals and be sure that you share similar ideals regarding training, showing, and horse care.

- All the trainers showed dedication to their horses' welfare through their training styles, scheduling, and care. Between frequent walk breaks, diversifying the training, and therapies, the trainers ensure that their horses are both physically and mentally balanced.
- Spending time with your horse prior to a training session helps you understand how your horse feels that day. This allows you to better plan for the ride.

Work/Life Balance

- A career in the equine industry is a "lifestyle and not just a job."
- Set clear expectations for clients from the start, such as setting office hours and requiring prompt lesson times. This will help set healthy boundaries between home life and work life.

Competitors

- It can be easy to become discouraged by seeing the success of others on social media. However, patience is crucial because your horse's needs are above all else.
- It takes collaboration and working with others to succeed.
- "Until it is my turn, I will keep clapping for others."

Training vs. Coaching

- Training occurs when a concept is being explained or demonstrated. It is the passing of knowledge on to another party.
- As riders grow, training should ideally start to take less and less precedence while coaching becomes more prominent.
- Coaching is focused on helping riders find the right answer rather than giving it to them, which increases their confidence in their skills and ability to apply those skills.
- It is our responsibility, as professionals (either aspiring or established), to teach our students how to be independent of us and develop confidence and understanding in their feel and ability.

Following the trip, Kylia Baker said, "This one-of-a-kind program afforded me so many spectacular networking and educational opportunities. The professional and personal connections I have made on this trip astound me and I am so excited to get started on the rest of my dressage journey!"

The Dream Program is heading back to Aachen, Germany!

In July 2025, TDF will once again take a group of top young professionals to the CHIO Aachen, where they will learn from some of the best riders, trainers, and judges in the world.





Breyer's New Salvino Model to Benefit The Dressage Foundation


This summer, a new model of Salvino was released as one of the newest additions to the Breyer stable! At the request of Betsy Juliano,



Leaving a Legacy

The Story of Judith C. Fiorentino and BG (USA Ret) Bill Fiorentino

When Judith Fiorentino joined our Century Club in 2014, she claimed that she was 30 years old and her beloved horse, Goliath, was 70. Her husband, Bill, recalls someone in the audience saying that the horse looked really good for his age!

That Century Club ride was the culmination of decades of riding experiences and education. From spending her childhood riding a pony named Trigger, to fox hunting and eventing, then finally to becoming a "dressage queen," Judith's equestrian life was all about learning and teaching others.

Along for the ride was Bill, who (with a twinkle in his eye and smile on his face) said, "My role was to do whatever she needed, but mostly stay out of her way."

When Bill and Judith started Steel Prize Stables in Alabama, Judith became a sought-after instructor for both youth and adults. Bill said, "I think her favorite things were the thrill of competition and the joy of watching her students advance in their riding skills. Seeing them compete successfully probably didn't hurt either. Having said that, it is important to know that she had several students who announced early on that they would never show, and that was okay with Judith as long as those students still worked hard on improving their riding."

As the years went on, Judith gained her own success in the arena, earning her USDF silver medal aboard Zeus and her gold medal aboard Goliath. As a capstone to all her achievements, Judith and Goliath joined the Century Club as Team #177 in 2014.

At the time of her Century Club ride, Judith said,


"I am first and foremost a teacher and it is my job to teach the joys of riding and barn-keeping to create better horse managers. I am justifiably proud of the many students who have gone on to achieve great things—not just in the horse world, but also in life in general. A teacher can have no greater reward."

When Judith passed away in 2020, one of her students said, "The dressage world is richer for having had Judith in our midst. She has left a legacy through her teaching, her support of educational programs, and her comradely support of fellow competitors."

Judith's legacy will not only live on through her students, but also through TDF's new "Judith C. Fiorentino Educational Fund," which will help provide educational opportunities to instructors who primarily teach low- to mid-level adult dressage riders.

Bill said, "Judith's core philosophy was that, while her students were important, the horse was her top priority. This led to her putting a provision in her Will that an endowed scholarship be established to help ensure that her philosophy would go on."

It is truly an honor for The Dressage Foundation to be the home of the Judith C. Fiorentino Educational Fund, which will help the next generation of dressage instructors in her memory.


