

Carol Lavell's Lasting Legacy

When Carol Lavell passed away on March 27, 2023, dressage-related social media and news sites were immediately flooded with stories of Carol, photos of her with Gifted, and memories shared from those who loved her and those whom she inspired. What Carol did for U.S. dressage on the biggest stages in the world was unequivocal. However, what she did for the sport behind the scenes has bolstered her legacy to unmatched heights—Carol made a lasting impact on dressage in our country that will carry on for generations.

For over two decades, Carol and her family helped countless riders through their financial support of The Dressage Foundation's grants. When the \$25,000 Carol Lavell Advanced Dressage Prize was first created, she said, "I hope this Prize will smooth the bumps for deserving riders and horses on the road to their dreams." Then she shared a story about the work, sacrifices, and struggles she overcame to reach the top of the dressage world, highlighting those who helped her along the way.

"For most, obtaining financial support becomes the ultimate hurdle," said Carol. "Some find that this goal can only be achieved by competitive success. Yet, success cannot be without failure along the way: Gifted was last in his first European Grand Prix. I discovered that 'acceptance' was not my strong suit.

"When an international trainer announced at dinner, 'You know, Carol, your horse will never win a medal with you riding,' I got motivation! Being last was past, but it would take more time, more coaching, training, and more dollars.

"The road to the top is very difficult: some ways are bumpier than others, some are more crooked, and some are dead ends. My Olympic dream came true only because my road was

paved with many generous supporters who gave not only dollars, but also tack, equipment, and even discounted transportation."

Carol's focus on helping others wasn't limited to those with Olympic dreams. Through her support of numerous Grant Funds at The Dressage Foundation—including the Carol Lavell Advanced Dressage Prize, the Gifted Memorial Fund for Adult Amateurs, the Major Lindgren Grants for Instructors, the Michael Poulin Dressage Fund, the Edgar Hotz Judges Fund, the Patsy Albers Award, and the Jack Fritz Grants for Young Professionals she helped thousands of amateurs, youth, young professionals, judges, instructors, and so many more.

May we all aspire to reach our dreams and help to pave the road for others along the way.

"I want to continue to spread the knowledge, experience, and lessons I learned during my training time. I think the idea of 'a rising tide raises all boats' is the cornerstone of The Dressage Foundation, and I couldn't agree more. I hope in this way we can not only benefit from Carol Lavell as individuals, but let it carry on to as many people as possible!"

Educating the Instructors

When Reese Koffler-Stanfield (KY) applied for a \$6,000 Major Anders Lindgren Instructor Grant in 2013, she said, "Although I have the privilege of helping my clients and students achieve their goals, my personal riding career and development has faced challenges due to shortage of time and budgetary limitations." The gift of a Major Lindgren Grant changed that.

With the grant, funded by Carol Lavell and her family, Reese was able to train for a concentrated time in Florida with Conrad Shumacher and Kathy Connelly.

Now, 10 years later, Reese and her students are still reaping the benefits of the time she spent continuing her own education as an instructor. She recently shared, "I am so thankful to TDF, Carol Lavell, and the Major Lindgren Instructor Grant. In the last 10 years, I've had the honor to coach many students in dressage, eventing, and show jumping, helping each rider achieve their goals, including rider medals and regional and national championships. I've continued to work on my own education by finishing the USDF FEI Instructor/Trainer Certification, along with many more clinics and symposiums. Financial support is a critical part of making those dreams achievable. I'm so grateful for the opportunities the Major Lindgren Instructor Grant provided."

Carol Lavell's support of U.S. dressage was deep and wide. TDF is honored to carry on her legacy of generosity, which will help the U.S. dressage community for generations to come.

The January 2023 Young Rider Dream Program trip to Wellington, Florida, was packed full of information, theory, techniques, and advice that all of us will remember and implement for the rest of our lives.

One of the week's recurring themes was the importance of slowing things down in training—ensuring the horses aren't being overworked, keeping the training process efficient, and maximizing the horses' longevity. We were also reminded that even top riders have their fair share of struggles. Patience and tactful riding are essential regardless of what stage you're at in the training process.

From lessons about dressage training to advice about life, here are some of our favorite tips:

 Debbie McDonald – Know your horse inside and out. Inspect them every day and know when they're even the slightest bit off. You're their voice, so it's your responsibility to advocate for them.

- Adrienne Lyle You must always think of how you can set the horse up for success.
- Betsy Juliano Care for the horse and horsemanship are important qualities that sponsors look for in riders.
- Dr. Hilary Clayton Be prepared to go slowly even if the horse is talented. Just because they can doesn't mean they should.
- Ali Brock Be persistent and continue pursuing your goals. If the opportunity isn't available now, it doesn't mean it won't be in six months.
- Charlotte Bredahl Come to shows with a positive, learning attitude. Choose to uplift the people around you. It doesn't go unnoticed.
- Katie Foster There is so much you can do
 in the horse world. You will find your niche if
 you take new opportunities when they arise.
- Jennifer Williams If you pour energy into one aspect of your life, it doesn't mean that (continued)

For Megan McIsaac (WI), recipient of TDF's Team Tate Mentorship and Leadership Fund Grant, that "time" meant the opportunity to develop as a trainer, instructor, business owner, and person.

Before leaving Wisconsin to spend three months training in California with Kathleen Raine, Megan said, "I am working on balancing my life between personal time versus professional time, my students' goals versus my own career goals, and simply running a business and developing a 20-acre farm. I feel so fortunate to be able to step away from my business to focus not only on my riding goals and to work with my dressage coach, but to be able to work on the further development of my business and leadership skills."

During her intensive training time, Megan had the chance to put herself first. She discovered the best investment she's ever made—herself!

"My greatest joy is training horses and developing our partnerships. To bring out the best in them motivates me to get up every day and give each horse 120%. However, just because professionals get the pleasure of riding every day, doesn't mean we don't struggle with all the pressures everyone else has."

In addition to training with Kathleen in the dressage arena, Megan shared, "The time spent in California was spent on reflection: what is working internally, what do I need to change within my business, what do I need to change within myself. I was with Kathleen every day, so I asked questions about everything—business, life, competition, ideas, morals, and ethics.

"I did some deep soul searching and made the changes I need to feel proud of my business and I am ready to continue for the next 20 years! Burnout is real, loneliness is real. So are connection, growth, and positive changes!"

Having the financial support, therefore the time, to make riding goals a priority is not an opportunity that was lost on adult amateur Deborah McAlexander (TX). As a visually impaired Grade V para-equestrian dressage rider, Deborah has overcome challenges with optimism, hard work, and dedication.

However, she still needed funding to reach her riding goals. Through TDF's Para-Dressage Fund Grant for Blind and Visually Impaired Riders, Deborah was able to dedicate time for 17 lessons with para-dressage coach Kai Handt.

Deborah shared, "This training has helped transform me from being a 'lovely passenger' into a kinder, more effective rider. Because of this ongoing transformation, my horse Noir is happily responding to my improved use of aids and the growing, joyful, unspeakable connection between us. I have received a confirmed classification for competition from the International Blind Sports Federation. My long-term goal is to meet the qualification to represent the United States in future international competitions. Noir and I will chase our dream, catch it, and not look back!"





Reaping the Rewards of Cynthia's Generosity



At the time of her application, Kate Tackett (NC) was just starting her career as a young professional. Her request for a grant to ride in a clinic with Scott Hassler gave Kate a chance to gain invaluable tools for teaching and training.

Kate said, "At the time, I was just starting to put together the pieces of Prix St. Georges,

and during my rides at this clinic, I was able to understand the quality and precision necessary for riding at the FEI level. Scott taught me to ride in a way that showcased the horse's strengths and improved her weaknesses, which is something I now help my students to do."

Kate is paying the grant back in spades by sharing her knowledge with the next generation of dressage riders. She recently shared, "I love working with young riders because of the energy they bring to the sport. They come to each lesson ready to learn and excited about how they can improve with their horses. They ask questions that push me to explain theory in creative ways and help me to think outside the box. Most importantly, in witnessing their passion they provide a constant reminder of why we all fell in love with horses."
